VICTIM OF HUMAN TRAFFICKING

- You received a proposal for a job well paid, in country or abroad
- You were told that the transport, accommodation and food are provided
- You fell in love with a man who proposed to get married and make money
- You travelled without knowing the route or destination
- You were transported in different places
- You were locked up and you were not allowed to get out
- Your documents have been taken from you
- You were forbidden to contact your family or friends
- You were to work many hours, without break
- You were not paid or the amount of money you received was very small
- You were to do things you did not want to do
- Someone you to do illegal things
- You were threatened, you or your loved ones
- You were beaten
- You were deceived

CIVIL REMEDIES REQUESTED FROM THE TRAFFICKER

SUFFERING = DAMAGES

- Your right to receive an amount of money because you are the victim of a serious crime which caused you suffering
- Physical pain
- Psychological suffering
- Humiliations
- Belongings were taken from you
- The money you earned were taken from you
- You got sick and needed or need medical treatment
- Your relations with the family, friends or persons around you have changed
- You lost the confidence in self and in others
- You are ashamed
- You are afraid

Your life has changed

The law gives you the right to request an amount of money from the person who caused you this suffering and if you do not obtain the money from this person, you can request an amount of money from the state

! YOU HAVE TO KNOW THAT THERE ARE CERTAIN TERMS AND CONDITIONS WHICH YOU MUST RESPECT IN ORDER TO BENEFIT OF THIS RIGHT

It is very important to know and to understand these terms and conditions, from the beginning, immediately after you were identified

WHAT YOU HAVE TO DO and WHO CAN HELP YOU?

**Inform the police within
60 days about what has
happened to you**

Give as many details to the policeman
and then to the prosecutor and
attorney about all situations and
persons who caused your suffering

AGREE

**to become a civil party in
the criminal proceedings**

- It is the main condition in order to request an indemnity from the trafficker
- It is important to become a civil party as soon as possible
- Keep (and make copies of) all receipts, invoices of the expenses made and which are connected to what happened to you

**You can ASK MORE INFORMATION
from the policeman,
prosecutor, attorney**

- The state provides you an attorney free of charge
- The attorney is the specialist who can help you the most. Ask his/her advice!!!
- It would be better to have the same attorney until the end of the criminal proceedings

WHAT YOU HAVE TO DO and WHO CAN HELP YOU?

After the criminal proceedings have ended
and you have obtained the final decision
through which you were granted civil
indemnities



Turn to a bailiff IF THE
TRAFFICKER DOES NOT PAY
YOU the indemnities but



You will need
MONEY FOR
FEES



IF YOU DO NOT HAVE MONEY,
you can ask in writing to the Court in your county the
help of an attorney and the amount necessary for the
enforcement of the court decision through which you
were granted indemnities

FINANCIAL COMPENSATION REQUESTED FROM THE STATE

If you still did not obtain the money from the trafficker because he/she has no assets or income to pay you

YOU CAN REQUEST A FINANCIAL COMPENSATION FROM THE STATE IN ORDER TO RECOVER YOUR MONEY PAID FOR

- Medical treatments. Keep all receipts!!!!
- Assets destroyed or damaged during exploitation
- The amounts of money which were not paid to you, if you were exploited through forced labour

HOW DO YOU PROCEED?

- Submit a request to the court in your county within one year from the date of the final decision
- Provide receipts and invoices for the spent money
- Provide evidences that the trafficker has no money or assets in order to pay you the established civil remedies
